Руководствуясь Федеральным законом от 06.10.2003 № 131-ФЗ «Об общих принципах организации местного самоуправления в Российской Федерации», Уставом города Железнодорожска Курской области, решением Железнодорожской городской Думы от 10.07.2024 № 149-7-РД «О внесении изменений в решение Железнодорожской городской Думы «О бюджете города Железнодорожска на 2024 год и на плановый период 2025 и 2026 годов», в связи с изменением лимитов бюджетных обязательств на 2024 год и на плановый период 2025 и 2026 годов, Администрация города Железнодорожска **постановляет:**

1. Внести в постановление Администрации города Железнодорожска от 20.12.2023 № 3212 «Об утверждении плана и детального плана-графика реализации муниципальной программы «Организация предоставления населению жилищно-коммунальных услуг, благоустройство и охрана окружающей среды в городе Железнодорожске» на 2024 год и на плановый период 2025 и 2026 годов» следующие изменения:

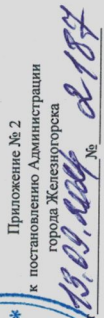
